## Act on Establishment of Government Organization, B.E. 2496 (1953)

BHUMIBOL ADULYADEJ, REX;

Given on the 6<sup>th</sup> Day of February B.E. 2496;

Being the 8<sup>th</sup> Year of the Present Reign.

His Majesty King Bhumibol Adulyadej is graciously pleased to proclaim that:

Whereas it is expedient to have the law on establishment of government organization;

Be it, therefore, enacted by the King, by and with the advice and consent of the House of Representatives, as follows:

**Section 1.** This Act is called the "Act on Establishment of Government Organization, B.E. 2496 (1953)".

**Section 2.** <sup>1</sup> This Act shall come into force as from the day following the date of its publication in the Government Gazette.

**Section 3.** When the government considers it is appropriate to establish an organization, with paid up capital from government budget, so as to provide public service, or for economic benefit, or for raising up of living standard of the people, or for public facilitation, this shall be executed by issuing the Royal Decree.

**Section 4.**The government organization established under this Act shall be a juristic person.

**Section 5.** The Royal Decree establishing the organization under section 3 shall contain the followings:

- (1) name of the organization;
- (2) site of its head office;
- (3) objectives of the organization;
- (4) paid up capital;
- (5) benefit distribution:
- (6) control and administration of the organization as well as the powers and duties of the committee, the director or the manager, as the case may be;
  - (7) accounting, audit and evaluation;
  - (8) other regulations necessary for running the organization smoothly.

**Section 6.** Abolition of the organization according to this Act shall be executed by issuing the Royal Decree with asset management procedures.

**Section 7.** The Prime Minister shall have charge and control of the execution of this Act.
